



Consideration of some of the recently issued Government Orders in connection with the forthcoming admission of students to the 1st year B.A/B.Sc./B.Com. courses:

- Reservation of OBC category of students [10% for OBC(A) and 7% for OBC(B) as per G.O. No. 07-Edn(U)/1U-89/13.- dated. 02.01.2014] in admission from 2014-15,
- Online admission of students in undergraduate courses from the academic session 2014-15 as per G.O. No. 83-Edn(T), dated 28.02.2014
- Authenticity verification of caste/tribe/class identification certificate and Domicile certificate (G.O. No.67-Edn(U)/1U-89/13 dated 16.01.2014 and No. 07-Edn (U)/1U-89/13.- dated. 02.1.2014.
- Horizontal reservation of students with disabilities during admission as per G.O. No. 65-Edn (U)/1U-89/13, dated 16.2014.

Observation of the Internal Quality Assurance Cell

(Meeting of IQAC dated 11.03.2014)

1. There was no provision of reservation of candidates belonging to OBC (OBC-A and /OBC-B) categories. However, the State Government has issued a notification bearing No. 07-Edn(U)/1U-89/13.- dated. 02.01.2014 and directed the authorities of the colleges and universities to secure admission of candidates belonging to OBC-A and OBC-B categories to 10% and 7% of the seats respectively without decreasing the seats already reserved for candidates belonging to SC and ST. The Government Order further stressed that the goal of 10% and 7% reservation of OBC-A and OBC-B candidates must be achieved within a span of 6 Academic Years. The members of the Internal Quality Assurance Cell (IQAC) arrived at the unanimity after holding detailed discussion on the issue that the matter must be brought to the notice of the Governing Body before execution of the directives of the Government Orders under reference.
2. The Government issued a notification bearing No. 83-Edn(T), dated 28.02.2014 directed the authorities of the undergraduate colleges to ensure admission process for admission to the undergraduate courses through *online* process in terms of the Government Order under reference. The members of the Internal Quality Assurance Cell (IQAC) were convinced after a detailed discussion on the issue that the matter must be brought to the notice of the Governing Body and subsequently the Admission Sub Committee be appropriately advised for properly implementing the directives of the Government Order under reference.
3. The issues regarding the authenticity verification of caste/tribe/class identification certificate and Domicile certificate in terms of Government Order No.67-Edn(U)/1U-89/13 dated 16.01.2014 and No. 07-Edn (U)/1U-89/13, dated. 02.01.2014 must be duly discussed in the meeting of the Governing Body.
4. The members of the Internal Quality Assurance Cell thoroughly examined the contents of the Government Order bearing No. 65-Edn (U)/1U-89/13, dated 16.2014 concerning horizontal reservation of students with disabilities during admission to the different undergraduate courses. The Government Order directed the authorities of the

undergraduate colleges to ensure 3% reservation of PwD candidates in every category, viz., UR, SC, ST, OBC-A, and OBC-B. The members of the IQAC thought it reasonable to request the Principal to kindly apprise the Governing Body of the college regarding the Government Order under reference.

Resolution

The Principal be requested to kindly take necessary measures so that the Governing Body of the college may appropriately be appraised regarding the Government orders bearing Nos. 07-Edn(U)/1U-89/13.- dated. 02.01.2014, 83-Edn(T), dated 28.02.2014, 67-Edn(U)/1U-89/13 dated 16.01.2014 and No. 07-Edn (U)/1U-89/13.- dated. 02.01.2014, and 65-Edn (U)/1U-89/13, dated 16.2014.
