These two institutes, one in the field on Higher learning of academics (under Higher Education Department, Government of West Bengal) and other being in the field of Games and Sports share common values of interest in the academic circle in broader sense. Both the Institute recognizes their strength in the field of Ang mentation of mental health, Skill Development in Sports and Value Education.

Dinabandhu Andrews College, Garia and Bengal Chess Association therefore agree to establish a programme for academic cooperation in the areas of mutual interest and in accordance with terms and conditions set forth in this memorandum of Understanding (MOU).

Objectives

- Exchange on to a basis of students at Undergraduate, Graduate levels for limited periods of time for purpose of Games and Sports.
- (2) Organize various workshops on Entrepreneurship Development in the field of traditional sports.
- (3) Conduct practical trainings on Sports organization and related career Development like a arbiter, coach etc.
- (4) Jointly organize seminars, conferences or workshops on topics of mutual interest and to invite other's faculty and students of nearby college to participate therein.
- (5) Help each other arrange the placement of trained students in the field of Sports.
- (6) Exchange students to participate on internship programme on Sports Science and Value Education.

Exchange of Scientific and Technical Material

Dinabandhu Andrews College, Garia and Bengal Chess Association will exchange information on educational programmes and teaching/learning material and other literature relevant to their educational programmes.

Joint Conferences, Workshops and Short-term courses

Dinabandhu Andrews College, Garia and Bengal Chess Association agree to help identify and invite faculty members from other institution to participate in conferences, workshops and short term courses related to value education and in the field of Games and Sports.

Student Exchange

Dinabandhu Andrews College, Garia and Bengal Chess Association, agree that student exchange will be guided by principles listed below. A home institution refers to the institution where a student is a full time student and from where he/she is expected to graduate. A host institution refers to an institution that receives a student for a brief period of time to undertake a predetermined programme of study or research.

- (a) Exchange students will be selected by mutual agreement between the home institution and the host institution.
- (b) An exchange student will continue to be treated as full time student at his/her home institution.
- (c) An exchange student will be considered as full "exchange": student at the host institution.
- (d) His/her programme of study at the host institution will be determined by mutual consultation between his/her academic advisor at the home institution and his/her "interim academic advisor identified by the host institution.
- (e) The host institute will evaluate an exchange student's performance in each course or module, award a letter grade or marks and issue a letter to that effect.
- (f) The home institution may award to the exchange student credits earned at a host institution, but only after the home institution has established correspondence between courses taken at the host institution vis-a vis those offered at the home institution.

(g) If an exchange student has undertaken research then the host institution will evaluate the exchange student's performance in the research and issue a letter to that effect, together with a

technical "report" of the research carried out.

(h) The exchange students will continue as usual to pay tuition and other fees at their home

institution.

SCOPE OF THE MOU

(1) Both the Institutes believe that close cooperation between the two would be a major benefit

to the student community to enhance their skills and knowledge.

(2) Exposure provided to students through this association will build confidence and prepare

the students to have a smooth transition from academic to working career.

(3) The students will enrich themselves with the knowledge through the programme on the

emerging technologies in order to bridge the gap in skill and make them ready for industry.

(4) The students of the two Institutes through this association will build their mutual value

added knowledge, ethics and responsibility towards environment and society.

VALIDITY

(1) The validity of the agreement is five years from the date of agreement and may be continued

thereafter suitable review of the agreement.

(2) Either institution may terminate the MOU by giving written notice to the other institution

six months in advance. Once terminated, Dinabandhu Andrews College, Garia and Bengal

Chess Association will be responsible for any losses financial or otherwise, which the other

Institutions may suffer. However, Dinabandhu Andrews College, Garia and Bengal Chess

Association will ensure that all activities in progress are allowed to complete successfully.
